• Reach Foundation – Dan Boyd

Mr. Boyd did not attend the July 8, Reach Foundation meeting. Ms. Sharpe reported that planning for the October 24, fundraiser, Spuds n Suds, is moving along well. The fundraising goal is set at \$100,000. Four sponsorship levels defined: Diamond \$5,000; Platinum \$3,500, Gold \$2,000; and Silver \$1,250. Reports from Mr. Dunwoody, Treasurer, indicate that the endowment is performing well. The foundation made \$75,000 distribution from the endowment to the Richland PFD. Reach Foundation Bylaws and Foundation Agreement shared with

members for review, comments and changes. Two new foundation members will be nominated at the next foundation meeting.

REPORTS AND CORRESPONDENCE

• Executive Director's Report – Rosanna Sharpe

Ms. Sharpe shared highlights of the April REACH Museum Executive Director's Report.

- 10th Anniversary programming is performing well beginning with the Saturday, July 6, STEAM Workshop and the opening of the 10th Anniversary Exhibit. The first Tuesday Free Day brought in 288 visitors and last Tuesday almost 500 visitors. Members Appreciation Day and Reception is Tuesday, July 23, Manhattan Project National Historical Park Rangers will provide special programming on the B Reactor in Gallery II. The Membership Drive offering 10% off new memberships during the month of July and current members a 20% store discount.
- Ms. Sharpe invited RPFD board members, foundation board members, and staff to tour the Mammoth Dig on August 8, at 8:30 am, and to tour WSU Hanford History Project on August 29, from 3:00 to 5:00 pm. Ms. Sharpe will send additional information and directions before the tours.
- Ms. Sharpe and Mr. King met with Joe Schissel, Deputy City Manager, to review founding agreements between the city and the RPFD. A punch list of accountability with the City, Corp, and RPFD, obligations and compliance.
- Ms. Sharpe and Mr. Landers are working on incorporating the recommendations from the RPFD, adding key performance indicators to the Strategic Plan.
- Replacement of the REACH servers will commence over the weekend.
- The 1940's Hanford Trailer and 1950's GMC Bus exhibits are open.

NEW BUSINESS

• Election of New Officers

Mr. King informed members that in the past if board vacancies are pending nominations of officers were postponed until those vacancies were filled. • Strategic Planning for Joint City Council & Richland PFD Workshop

Mr. King stated that he sees this discussion in two parts, strategic planning for the museum and the Richland PFD's role, especially when taking on a new project. The decision was to have a workshop to discuss strategic planning. Mr. Wiley has suggested that strategic planning for the museum should be a separate workshop. The Richland PFD has different goals and deliverables than the museum. Mr. King suggested postponing the workshop until the new board members are in place. Members will be polled in early September for available dates and times.

Mr. King provided a draft agenda for the August 27, Richland PFD and City Council Workshop. Introduction and bullet points. Members agreed with the outline of the agenda to include in the introduction "What is a Public Facilities District (PFD)", "Where we as a PFD are going, and the Concept". Discussion and Questions will be moved to the end of the agenda. Staff will provide the details of the presentation. Time limit allotments to be consider.

OLD BUSINESS

• Revised Proposed Strategic Plan - Alan Landers

At the June Richland PFD meeting board members requested that Key Performance Indicators (KPIs) be added to the Strategic Plan. Mr. Landers reported that he did not create specific KPIs to each activity, things emerge and it is hard to predict. Instead, update the KPIs as we move through each project.

- Not enough items
- Add comparisons
- Broader scale engagement
- Plan is a little vague
- Don't disagree with specific, a great starting point
- A living document
- Disappointed. The transition of supervision from the Richland PFD to the Reach Foundation is not in the Strategic Plan
- It could be a Reach Foundation Strategic Plan
- If the museum is going to be transitioned, what does that mean, how we approach it
- Two levels: commit to the idea that we are going to transfer oversight of the museum and how the foundation structures themselves

- Organizational change, a major undertaking

Mr. Landers provided his process on organizational development for putting a plan together. His goal was to create a plan for financial stability for the museum, to address concerns of the REACH Museum's viability and what we can do within our control and then modify as we move forward. Mr. Landers is committed to keeping the museum viable and functional.

NEXT MEETING

The next Richland PFD meeting is on August 15, 2024. Ms. Sharpe will attend remotely; she is on a grants panel for Building for the Arts in Olympia.
