The Reach Foundation approved \$6,000 for Tere Thornhill's Phase 1: Programming and Preliminary Cost Analysis at the June 10, board meeting. Kristin Lerch, Foundation board member is the committee chair for the Spuds n Suds fundraiser. The committee will convene to start planning for the October 24, 2024, fundraiser. Mr. Boyd reported that the endowment is performing better and backup to 1.5 million.

REPORTS AND CORRESPONDENCE

- Executive Director's Report – Rosanna Sharpe

Ms. Sharpe shared highlights of the April REACH Museum Executive Director's Report.

- The team is preparing for the REACH 10th Anniversary programs scheduled for the month of July.
- Sponsorships secured for the Free Admission Days at the REACH are City of Richland, City of Kennewick, City of Pasco, City of West Richland, Port of Benton, Benton Co. PFD, Pasco Chamber of Commerce, and Pasco-Kennewick Rotary.
- 2023-2024 school year ended with 71 field trips serving over 3,000 students. Battelle sponsored costs of field trips to schools in need of financial assistance.
- The Strategic plan 2024 – 2026 is in final stages of completion.
- The Reach Foundation authorized the Tere Thornhill's Fee Proposal and Letter of Agreement for Phase 1: Design, Programming and Preliminary Cost Analysis
- Ms. Sharpe met with Alan Brecke regarding a Columbia Center Rotary Club's Special Projects Committee to discuss the outdoor amphitheater.
- Ms. Sharpe presented to the Sunrise Rotary Club on June 19th
- Ms. Sharpe met with Becky Burghart, Manhattan Project National Historical Park and Wendy Berhman, Superintendent for the National Park Service.

BUGET COMMITTEE

- 631 Fund \$75,000 Transfer Request

Ms. Sharpe presented the request for the scheduled transfer of \$75,000, as budgeted, from the 631 Fund. The 2024 Budget amount for 631 transfers is \$300,000, year-to-date total transfers is \$200,000.

Ms. Kerzner moved and Mr. Wiley seconded a motion to approve transferring \$75,000 from the 631 Debt Service Fund

NEW BUSINESS

- REACH Strategic Planning Retreat – Steven Wiley

Mr. Wiley opened for discussion a Strategic Planning board retreat to establish concrete plans prior to the Richland PFD and City Council workshop. To flush out the details and set strategic goals. Mr. Wiley would like to see a tactile component in the strategic plan. Board members agreed that including metrics in the plan will provide clarity.

Ms. Sharpe and Mr. Landers will revise the draft plan adding metrics and deliverables and will present at the July Richland PFD meeting.

- Visioning Workshop for Columbia Park West – Steven Wiley

Mr. Wiley proposed a Columbia Park West visioning workshop for all stakeholders. He would like the workshop scheduled in June or July and has a list of stakeholder for invitations. He will provide 2-3 week notice to board member.

- Proposed Strategic Plan – Alan Landers

After discussion under REACH Strategic Planning Retreat, Mr. Landers and Ms. Sharpe will revise the draft Strategic Plan with the action items identified. The draft plan will be presented at the July Richland PFD meeting
