Mr. Boyd updated the Richland PFD of Reach Foundation activities. The next foundation meeting is July 21. The foundation board members are working on the application for board member liability insurance, to be addressed at the next meeting. Fred Raab, the previous Head of LIGO and Past President of the Richland PFD Board, is the honoree at the August 21 Spuds n Suds fundraiser. Dr. Raab was instrumental in building the REACH Museum and presided during construction; he led us through it all. If not for Fred, the museum may not be here. Dr. Raab is a Reach Foundation Patron and long-time donor for the last sixteen consecutive years. He is also a Legacy Member of the REACH Museum. Mr. Boyd continues to build on the Patrons Program. The foundation will be updated on the investment accounts at the next foundation meeting and will report back to the Richland PFD Board.

# REPORTS AND CORRESPONDENCE

• Richland PFD President's Report – Steven Wiley

Mr. Wiley reported to members his meeting with Mark Greenough, Richland PFD legal counsel, regarding Richland PFD setting up independent accounts, matching funds for the bond refinance, and MOUs with community partners.

Issues discussed regarding RPFD bank accounts as long as the bank is a public depository, which all local banks qualify. As suggested by legal counsel, the simplest method is to set up sub-accounts for the RPFD that are restricted accounts for RPFD-authorized expenditures. Mr. Wiley will request a motion to approve this action later under the New Business item.

The original authorization of the bond for the REACH stipulated that, in addition to the RPFD tax, a 33% cost-sharing is required. As stated in the Interlocal Agreement with the city, \$125,000 in Hotel/Motel tax is contributed. Refinancing the current bonds with outstanding debt of 1.6 million, we are not required to do the match. The interlocal agreement that we signed with the city to keep the hotel-motel tax had to specify that it was essential to tourism and the funds to continue until the bond is paid off. We do not need to have matching funds to pay off bonds. Passed into law this year is the requirement that there is a 33% match for new debt. Once the interlocal agreement is fulfilled, all money in reserve can be transferred to RPFD accounts. Taking on new debt is more than expected, a lot more work. Refinancing the bonds will provide a significant cash flow.

Mr. Wiley met with Joe Schissel and Mike Rizzitiello, the new City Development Services Director. Mr. Wiley shared the Richland PFD strategic planning and discussed the redevelopment of all the Columbia Park West and the communications plan to share the RPFD vision. They had no objections, and they were very enthusiastic and pleased with the plan. The city approved the original Columbia Park West Masterplan.

- Executive Director's Report Rosanna Sharpe
- Ms. Sharpe shared highlights of the July REACH Museum Executive Director's Report.
  - REACH Museum staff held a retreat on June 23 to review the Quarter 3 and Quarter 4 operations plan. The Strategic Leadership Team is finalizing the 2025-2026 Strategic Plan for review and approval by the Richland PFD and Reach Foundation.

- The REACH community free day sponsored by Tri-Cities Sunrise Rotary is on July 24. The REACH will celebrate our 11<sup>th</sup> anniversary on this day by extending museum hours, family activities, and a custom cookie giveaway. Members will receive a REACH Museum lapel pin as a token of appreciation.
- Sponsors secured to date for the Spuds n Suds fundraiser are Pasco Chamber of Commerce, RBC Wealth Management, High Street Insurance, In Balance CPA Group, and Reser's Fine Foods. Swampy's BBQ and CG Catering will cater the event.
- PNNL celebrated its 60<sup>th</sup> Anniversary on July 9, and community leaders attended the event. REACH staff are working with PNNL's design team to organize a 60<sup>th</sup> Anniversary exhibit in the Hoch Gallery from October 4 to January 3.
- Patt Mosely presented the July REACH Museum Website and Social Media Performance Summary.
- RPFD Finance Committee Report Ted Miller

Mr. Miller had nothing new to report from the Finance Committee this month.

• RPFD Transition Committee Report – Doug McMakin Mr. McMakin shared the transition white paper with RPFD and Foundation board members, but has not received feedback.

#### **NEW BUSINESS**

• Set Up a Sub-Account for the RPFD, Specific Expenditures – Steven Wiley To prevent the REACH and Richland PFD from getting into audit issues, set up sub-accounts. Within the master bank account, there will be sub-accounts with restrictions. The city can deposit into a sub-account, which will require a vote by the PFD board to transfer the 631 funds from the city to provide better transparency.

Mr. Wiley moved, and Mr. Wiemers seconded a motion to set up a sub-account to the current Richland Public Facilities District account at Community First Bank that is restricted to funding Richland Public Facilities District expenditures only.

• City Officials Communication Plan – Steven Wiley

Mr. Wiley informed members to help in communications with the city officials, city council, and community advocates, a monthly Richland PFD newsletter, using AI to summarize. Mr. Wiley will personally review for accuracy. Finances, metrics to reflect museum performance. The Richlandpfd.org domain is secured, and an RPFD icon has been created. The RPFD will have a separate identity, sharing the vision, minutes, performance, and information.

• Bond Refinance – Steven Wiley

Mr. Wiley Hilltop Security, working with the state PFD meeting, is a good place to start. Michael Neuman is the correct contact at Hilltop; he is replacing Lindsey Sovde. Mr. Wiley asked that the Finance Committee contact Hilltop and work out the details of the bond refinance.

Mr. Wiley opened for nominations for President, Vice President, and Treasurer of the Richland Public Facilities District.

Mr. Rosenberg nominated, and Mr. McMakin seconded the nomination of Steven Wiley as President.

Mr. Miller nominated and Mr. Rosenberg seconded the nomination of Doug McMakin as Vice President

Mr. Wiley nominated and Mr. McMakin seconded the nomination of Ted Miller as Treasurer
